- The software will be deployed in an optimized and scalable manner. It should adhere to the continuous integration and continuous delivery (CI/CD) principle. The development should be cloud-native i.e., migration of any part at any time to public/private cloud should be seamless.
- It is expected that the firm will develop a customized solution for the proposed system. Use of open source technology will be recommended unless justified otherwise to prevent unnecessary use of licensed tools/technology/database. Any such use of licensed tools/technology/database must be pre-approved/endorsed by the Client and/or its Nominated Consultants.
- The firm must follow a well-defined software development process to meet the SQA (Software Quality Assurance) criteria specified by the nominated Consultants and followed by standard industry practices.
- The Software must have the provision for extensive configurability and parameterization to ensure easy maintainability.

- It will be a fully bi-lingual (Bangla and English) system.
